#### <u>**President's Report**</u> – Presented by Marcia Demos.

This bridge year has gone by so quickly for me, and I have had to look at bridge differently. I can no longer just breeze in, play for a few hours, have a few laughs, and then breeze back out the door. Since becoming your president, I can no longer consider myself a retired person.

I have had to question just how the MBU works and to actually pay attention to just what was happening around me. Bridge here does not just happen, it takes planning, work, and enthusiasm. In 1932 the ABA was organized because Black bridge players were excluded from most bridge events. I can only imagine how much work went into starting and growing an organization from the very beginning.

We are fortunate today that the ABA still exists in a world where there is so much competition for our time and attention. We are also fortunate that our bridge association is different from any other.

We are a nonprofit organization and our focus is on the "social experience" not on dollars and cents. We can afford to take the time to truly nurture our new players, to take the time to celebrate birthdays and club anniversaries, and to reach out to our missing members that seemed to fall out of touch.

Last week I went to the graduation of one of Annetta Wallace's New {layers' class. There was much pomp and circumstance. The Bridge Home President, the Eastern Section Vice President and I spoke of how great it was to see such an interest in bridge and all it has to offer. I presented the graduates with beautiful certificates, acknowledged all new players in the room, and preserved the moment with a gallery of pictures. At this same celebration, the Cosmopolitan Duplicate Bridge Club marked their 63<sup>rd</sup> anniversary and served a lunch fit for a King, cake and all. We may be nonprofit, but we can afford to be family to our members.

As the MBU prepares for our only tournament of the year in December, I have become aware of all that goes into making a major event happen. The planning for the tournament begins a year in advance. Contracts to be negotiated and signed, the AAA committee is formed to work out the details, and fundraising events are planned to make sure that we will be able to pay for all the amenities and expenses that we are responsible for, such as staff housing and salaries, the yearly brunch with entertainment, hospitality and decoration expenses that make the AAA tournament so special. The MBU's AAA is the best Unit tournament in the country and it is a game that rivals all other games in the ABA.

Remember, the MBU is a voluntary organization. The different flyers that announce a game at many venues, are done without pay (thanks to Rita). Many expenses are donated, and your elected officers that put in their time and energy to make Bridge "happen", all work without pay. From the person that keeps track of your money to the one that keeps track of your points, to the ones that order the supplies for the games you play, all

work for free and are underappreciated. Would you believe that we cannot even get new people to work on The Consumer, that we all say we want.

When I became your President, I promised two things. One, there would be transparency, and two, I would do the best I could. So far I have kept my two promises. I won't duck hard decisions, and I will take responsibility for what I say.

Now, having said all of that, my job right now is to try to get more members, and to get our present members more involved. Your elected officers are some of the hardest and most dedicated people I have ever met. They have been patient with me and kept me from making too many mistake as I learn to do the job you entrusted to me. All I ask of you, is if you have a problem with something that is being done, let us know, and be a person right in the middle of getting the problem fixed.

The MBU has had problems that originated with the pandemic, and some of those problems have continued until today. We need to be on firm financial footing as we go forward so that the bridge game we know and love will continue.
